Investigative Supplemental Report

Premise: 840 5th St

Date: 10-27-20

Suspect: Gavin Johansen- 04-24-02

Involved: Mark Davis- Case Worker

Witness: Summer Gillespie (girlfriend of Gavin)

Officer Involved: Officer Wendi Rhodes (OPD)

I was advised that there was an officer involved critical incident at the location of 840 5th St in Ogden City. The Force Investigation Protocol had been followed and the investigation would be turned over the Weber County Attorney's Office.

I arrived on scene and was advised that the Ogden Police Department officers had responded to this residence on the report of a suicidal person. It was reported to dispatch from a case worker that a Gavin Johansen was at this residence and intended to commit suicide. There was also a report that Gavin was going to use a shotgun that was inside this house to kill himself.

When officers arrived, a male exited the house and was shot by an Ogden Police officer. A handgun and a large knife were found next to the male when he was treated medically for a gunshot wound.

Body cameras were being collected from officers who were on scene. Officer Rhoads of the Ogden Police Department was the officer who fired. She had been taken to the Francom Public Safety Building and sequestered.

I then was pointed out to the case worker who had originally called 911. His name was Mark Davis and he had responded to the residence and was on scene. I made contact with Davis and asked him if we could speak privately. I had Davis sit in my vehicle and I recorded the conversation with a digital audio recorder.

Davis advised me that Gavin is currently in the custody of the State of Utah and does not live at this residence. This is Gavin's parent's residence and was his house until he was placed into the State's custody due to a sexual assault conviction. Gavin lives in a group home in Layton City.

Davis told me that some of Gavin's privileges had been taken away from him today because of poor behavior and lying about his getting fired from a job. Gavin was being allowed to use a vehicle owned by his parents and it was decided that Gavin would be losing this privilege. Davis said they met with Gavin this afternoon to tell him about this and then searched his vehicle. Alcohol and vaping paraphernalia had been found. The vehicle was taken and returned to his father. There was some unknown damage to the rear of the vehicle as well. Davis left Gavin in the Layton house at 1430 hrs.

Davis said at 1745 hrs he was advised that Gavin had walked away from the group home without permission. Davis said they started trying to learn where he had gone. Davis said it was a concern because Gavin had been depressed over losing his privileges. It was suspected Gavin would be headed to his parent's residence. Davis contacted Gavin's mother, Becky, and she did not know his whereabouts.

Gavin was contacted by text message. Gavin made statements that he did not care because everything had been taken from him. Davis looked on his phone and found that at 1903 hrs, Brittney called Davis and told him that a girlfriend of Gavin's named Summer had text messaged her and said that Gavin was headed to Brittney's house to get a shotgun and commit suicide. Davis said that Brittney was not at the house and it sounded like Gavin was still enroute there. Davis called 911.

Davis said he relayed this information to Weber Dispatch and then responded to the scene. Davis said when he arrived the incident involving the officer had already taken place and he did not observe anything notable.

I thanked Davis for his time and ended the interview.

Myself and Detective Endsley went to the Francom Public Safety Building. I was advised that Officer Rhoades was upstairs in the Investigations office. We made contact with Officer Rhoades and her FOP Attorney, JC Jensen. CSI Gerrard was already at the station and joined us in the Investigations conference room.

Photographs were taken of Officer Rhoades and how she looked at the time of the incident. I then removed the duty issued handgun from her holster and removed the magazine. I then ejected a bullet from the chamber that had not been fired. I then counted the remaining bullets in the magazine and found there to be 11 rounds. This was video recorded by CSI Gerrard. I then placed the handgun in a gun box and documented the make model and serial number (Glock 17 Gen 4 serial number).

I then removed one of the two spare magazines that Officer Rhoads carried on her duty belt. I counted 18 unfired rounds of 9mm ammunition. I then removed the second spare magazine and counted 17 rounds of unfired 9mm ammunition. All three magazines had a capacity of 17 rounds listed on the back side of the magazine. I inquired to Officer Rhoads about how many bullets she typically cared. Officer Roads explained to me that she would fill the magazine to capacity and did not count. Both magazines and all the rounds were collected by CSI Gerrard. Detective Endsley scribed the bullet count.

Officer Rhoades attorney agreed to advise me about Officer Rhoades giving a statement in the next few days.

I then went and met with Lt Ward of the Ogden Police Department. Officer Rhoades body camera was downloaded and I obtained a copy of it.

Detective Endsley advised me that he had been able to make contact with Summer Gillespie and she was willing to meet with us at an apartment that she was staying at in Layton City. Det Endsley and I went to meet with Summer.

We arrived and sat down with Summer inside the apartment. Det Endsley recorded this interview on his body camera and fully detailed this interview in his supplemental report. Summer told us that she had been in contact with Gavin in the afternoon through text messages. Gavin made comments that seemed ominous and she feared he was suicidal and when he stated he was going to his mother's house to say goodbye, Summer recalled Gavin make a comment in the past about using a shotgun at his parent's house if he was going to kill himself. Summer then messaged Gavin's mother Brittney and advised her of the situation.

Summer allowed me to look at this message thread that was through a Facebook messenger app. I used Det Endsley's body camera to document the messages. Summer gave a written statement.

After speaking with Summer we returned to the scene and joined back up with Investigator Zaccardi and CSI. I turned the body camera footage over to Investigator Zaccardi. The Farro 3D scans had been completed and photographs had been taken. I assisted in searching the SUV vehicle that Gavin had been driving. There were numerous real looking air-soft guns in the rear of the vehicle. They were photographed and left in the vehicle.

It had been determined that the gun that Gavin had in his possession on the stairs was in fact an air-soft gun. I observed this gun as it was being collected by CSI. The gun looked like an exact replica of a functioning handgun.

The evidence collection was completed from the scene and the house was released to Gavin's parents.

Investigator Zaccardi and I went to McKay Dee Hospital and collected Gavin Johansen when he was discharged. We took Gavin to the Weber County Attorney's Office and sat down with him. Investigator Zaccardi advised Gavin of his Miranda Rights and Gavin said he understood them and was willing to talk to us.

Gavin admitted to being suicidal and went to his parent's house to use a shotgun to shoot himself. Gavin said he broke into the gun cabinet by removing the screws on the lock hinges. Gavin also admitted to fighting with Andrew over the shotgun and choking him.

Gavin said he heard the police outside and decided he was going to make them shoot him so he grabbed his air-soft gun along with a large knife and then walked out the backdoor and went up the stairs towards an officer. Gavin said Andrew was trying to grab him and pull him back down the stairs when he was shot. Gavin then described that officers started treating his wound and medical arrived and took him to the hospital.

Gavin admitted in this interview that this was a suicide attempt. After the interview about this incident was over, I recalled reading how Gavin was a suspect in a hit and run and how there was unknown damage found on the vehicle he had been driving. I asked Gavin about being involved in an

accident and Gavin said he wanted an attorney. The interview was stopped and Gavin was taken to the Weber County Jail where he was booked.
